FTR Gold Format	This format must be played using FTR Player Plus™ which is available on the FTR Gold website <a href="http://www.ftrgold.com">www.ftrgold.com</a> . This software permits the listener to navigate through the recording by using time references from the actual hearing.
PC Audio Format	This format will play on most computers using standard PC software.
Generic Audio Format	This format will play on most players designed to play music and other audio programs.

**\$31 Fee (per CD)**

Pursuant to the Appendix to 28 U.S.C. § 1930 (Bankruptcy Court Miscellaneous Fee Schedule), there is a \$31 fee to reproduce an audio recording of a court proceeding. This fee is due with the filing of the request. This request must be filed with the clerk at **United States Bankruptcy Court, District of Hawaii, Suite 250, Honolulu, Hawaii, 96813**, accompanied by a cashier's check, certified check, or money order. Other checks are accepted only from attorneys admitted to practice in the District of Hawaii and only if the check is imprinted with the name of the attorney's law firm or client trust account. If filed electronically via ECF, online payment must be made using a credit card.
