- Email Bypass Notice to Debtor's Attorneys. The BNC process bypasses notices determined to be undeliverable by the U.S. Postal Service. Previously, the BNC would send a paper notice to the debtor or debtor's attorney that an intended recipient for a 341 notice was bypassed. After Release 4.1 is installed, BNC will transmit the bypass notice to the attorney's primary email address if the attorney is a registered ECF user. No paper bypass notice will be mailed.
- NEF Link to 341 Notice. Previously, BNC mailed a paper 341 notice (Notice of Bankruptcy Case & Deadlines) with the debtor's full Social Security number (SSN) to the debtor's attorney. If the attorney is a registered CM/ECF user, a secure link sent by email will provide one "free look" to the notice containing the full SSN. If more than one case is filed in a day, the BNC will send a summary email with multiple links.
