If there are matters scheduled, a bar at the bottom of screen will show the judge's name, together with the time of the first hearing for that day and the court location or that it is a Zoom hearing. Only the first hearing time will appear but the hearing details screen will display all matters for that date.

Instead of selecting a specific date, there are options to search by attorney, debtor name, and case number. In addition, personal preferences may be set by clicking on the "gear" icon in the upper left side of the screen.



Options for settings include whether to display canceled matters (shown with strikethroughs), and filters for type of case (bankruptcy, adversary proceeding, or miscellaneous proceeding), and chapter.
